Pittsburgh, Pennsylvania based fine artist Steph Moraca has been recreating the beauty of the outdoors in her realism landscape paintings for over eighteen years. An avid hiker and outdoor explorer, Ms. Moraca finds inspiration for her paintings while visiting national parks and other iconic nature scenes.

Ms. Moraca received formal art education at the University of Pittsburgh, where she graduated in 2012 with a Bachelor of Arts in Studio Arts. She continues to learn by attending professional workshops and participating in group critique sessions in several art organizations, including the Pittsburgh Society of Artists and Oil Painters of America. Her paintings have been juried into national level exhibitions and have received awards including Honorable Mentions and fanfavorites at public voting exhibitions. In addition, Ms. Moraca's work has been featured in newspaper publications and in local Pittsburgh magazines.

Ms. Moraca's intent with creating contemporary realism landscape paintings is to spark emotion and possibly bring up some memories for her clients as they view her work. "My clients feel a connection with my landscape paintings because they share the same love for nature and national parks as me - they often tell me stories about their memories of visiting the places I paint, and I enjoy listening and comparing their stories to my own experiences."

Her paintings are featured in the homes and businesses of private collectors throughout the United States.
